



1. I refer to your letter received at this office on 10 June 1987.
2. I wish to advise that a record of military service of John Fabian Fitzgerald, John Thomas Wells and William George Richards are held by this office. However, regulations preclude the release of information without the written consent of the ex-soldiers concerned; or if they are deceased a written statement from you to that effect will be required. Additionally, regulations require that you state your relationship to the ex-soldiers and the reason for your request. If you are not related it will be necessary for you to obtain the written consent of the ex-member's next of kin before information can be released.
3. From the information you have provided positive identification of records of Francis Paul Fitzgerald and Sarah Fitzgerald has not been possible.
4. I would be pleased to conduct a further search on your behalf if you can supply at least some of the following details:
 - a. Their Army numbers.
